Director's Report

- 1.) Official Invitation to bid on canopy roof has been issued and responses are due on December 7th.
- 2.) Enclosed in your packet is a template/example form of the G.O. Ordinance. Historically, the pricing comes in the day of (This Thursday). David will prepare and bring the completed document to the meeting and give a full explanation of rates and costs prior to consideration.

- 3.) Performed price comparison with other local golf courses, pools, as well as cost analysis on other programs. Attached are my findings and recommendations to be brought for discussion as we set rates for upcoming year.
 - a. Fuel and Labor are big drivers for costs at golf course.
 - b. Labor and chemical are drivers at Pool.
 - c. Labor is big driver of cost for programming.
- 4.) Invitation to bid has been issued and local contractors contacted on submission process.
- 5.) Dates have been set for "Holiday Shutdown" for 2022. Park Offices and facilities will be closed on the following: Thanksgiving day and day after ("Black Friday"). We will also observe Christmas Eve on Friday December 23 and New Year's Day on Monday January 2, 2023. All staff will be off during these times. We will, however, be ready to meet any demands that arise during these periods.
- 6.) Other Activities
 - a. Updated SAM(Federal Gov) and GATA(Illinois Grant portal)
 Information as required yearly.
 - b. Worked with our friends at Kewanee Walmart who donated left over potting soil to be used on a project Barb Salisbury is doing where she will plant wildflowers between skate park parking lot island.
 - c. Executed agreement with Mark Russell on farmland
 - d. Have begun conversations with Bi-state regional commission to prepare formal comprehensive plan and also planning and preparation for OSLAD 2023. They will offer assistance in form of templates and review while we compile and develop.
 - e. Participated in Central School's career fair
 - f. Issued bid invitation for stump removal at Chautauqua Park. Other Parks will most likely follow as we complete dead tree removal campaigns.

- g. Progressing and working with software companies to find the best fit and value for park district. I hope to have a proposal and recommendation next month.
- h. Inducted in as member of Elks as of this past Monday

7.) In the parks

- a. Spraying year end
- b. Closing down and winterizing, pool and shelter houses, fountain
- c. Shadowbox went down at Windmont due to wind as well as a tree on south end. Partial tree down at Northeast entrance during same timeframe.
- d. Completed concrete project on 16 tee box
- e. Planted first wave of Tree's from trees forever grant. Able to obtain more mature trees on year end deals. "Official" planting and public event slated for spring.
- f. Trenched in electrical for box at new maintenance building
- g. Planted 4 trees for Trees forever grant

Commissioner Heberer: Asked about getting the fence fixed that a car struck at Northeast Park. Director Dwyer said that it was repaired the best they could, the car was uninsured, and the repairs didn't meet the deductible. How much is it going to cost for Gutschlag to finish the new maintenance building that he is working on the electrical, & he would like a rough estimate of the costs.

Commissioner Kapacinskas: She seen on Facebook that Windmont need volunteers for Saturday the 19th it is a huge event for our community, wanted to bring to attention. Director Dwyer told her it was cancelled right before the meeting; they ran out of tape.

President Brackett: Gone through a lot of discussion good things here that we are doing. Like the fact to get insurance less than the year before.
