5. REPORT FROM DIRECTOR

- 1. Splash Pad. With delays, we are set to open Thursday. I am excited to bring this to our community.
- 2. TIF I spoke with Gary Bradley today and am going to set meeting with him and a council member, will be asking a board member with us to attend as well.
- 3. Weed notice. The city has again given us a weed notice for our property along Madison. We have a dedicated no-mow area that sits back anywhere from 20 to about 40 ft. I am working with Gary Moore to alleviate this moving forward. There is some legal precedent about governmental autonomy, and I believe this area falls under that scope. I spoke to Gary Bradley on it and he indicated Keith Edwards has taken it upon himself to make this an issue.
- 4. We had a hiccup with the city on the IGA about not billing us for sewer for the pool. For some reason City Manager said it was expired. I have worked with City water dept and mayor Moore to remedy.
- 5. Working with Abilities Plus about the property they own to the left of no 15 that is causing mudslides onto the pleasure drive. We hope to get out there and figure out what to do with it in near future.
- 6. Little Libraries will be going out into the parks very soon. We have locations spec'd and are only awaiting some decals.
- 7. Vandalism Still very bad. We continue to work on and are trying to get additional cameras on a cell network in place to help deter.

8. Other Activities:

- 1. Dog Park Grand Opening was a huge success
- 2. Held a discussion with our new Municipal advisor about our plans and tasks to complete for this years issuance and also about an alternative bond.
- 3. Day camp session 2 is full at 30 kids!

- 5. Working with Library to get little libraries out. They are bogged down on their decaling, and we are holding until they are ready.
